Rule 4120.2; 4120.4; 4120.3(A)(24) On May 9, 2025, the New York Drug Testing and Research Program reported to the New York State Gaming Commission that blood sample #CV3603026, submitted by the horse DIAMOND BEACH, post-race (Qualifier) on April 23, 2025, contained the presence of Ranitidine at a concentration above the permitted threshold. Pursuant to New York State Gaming Rules 4120.2; 4120.4; and 4120.3(A)(24), trainer Andrew Adamczyk is hereby fined the sum of \$500.00. Further the horse DIAMOND BEACH, is required to provide a negative sample for Ranitidine and re-qualify prior to being eligible to race. Having appeared before a representative of NYSGC and waived the right to a formal hearing and appeal, the fine is hereby reduced to \$250.00. (1st offense in this category in a 365-day period.)

Mr. Allard is fined \$300 for acting in a manner that reflects negatively on the sport and is inconsistent with the interests of racing. POSITIVE TEST- POST RACE

Paul Blumenfeld was the programmed trainer of the horse "EVAS SPORTS CZECH" when she raced in the seventh qualifying race at The Meadowlands Racetrack on April 19, 2025. Following the race, "EVAS SPORTS CZECH" was required to submit blood for analysis. A report from Industrial Laboratories identified the presence of Phenylbutazone above the allowable limit. As a result, Mr. Blumenfeld is fined the sum of five hundred (\$500.00) dollars. The time from the qualifying race is disallowed. Mr. Blumenfeld has waived his right to a hearing with the Board of Judges and has accepted the penalty associated with this ruling. The fine associated with this ruling must be received by the New Jersey Racing Commission on or before June 7, 2025. POSITIVE TEST- POST RACE

New Jersey Racing Commission (NJRC) licensee Per Engblom was the programmed trainer of the horse "Mon Amour" when he raced in the 6th race at the Meadowlands Racetrack on April 29, 2023 and finished in first place. Following this race, "Mon Amour" was selected to submit post-race blood and urine samples for analysis. A report from Industrial Laboratories identified the presence of Oxycodone, Carisprodol and Meprobamate, a metabolite of Carisprodol. At Mr. Engblom's request, split sample testing was performed at Texas A&M Veterinary Medical Diagnostic Laboratory, which is an approved independent laboratory. These testing results did confirm the presence of Oxycodone, Carisprodol and its metabolite Meprobamate. This is in direct violation of the rules and regulations of the New Jersey Racing Commission. An administrative hearing was conducted on December 6, 2023 in the Judges' office at the Meadowlands Racetrack to accept evidence and testimony regarding this matter. As a result of this hearing, the Board of Judges have determined that NJRC licensee Per Engblom was the programmed

trainer of the horse "Mon Amour" when he raced in the 6th race at the Meadowlands Racetrack on April 29, 2023 and the presence of these prohibited substances is in direct violation of N.J.A.C. 13:71-23.1, and N.J.A.C. 13:71-23.6. As a trainer licensed by the NJRC, Mr. Engblom is the absolute insurer of and responsible for the condition of a horse within his care and custody and shall not enter or start a horse that has in its body any drug or substance foreign to the natural horse. As a result of the evidence and testimony presented at the administrative hearing held on December 6, 2023 regarding the post-race positive test from the horse "Mon Amour" for the drug Oxycodone on April 29, 2023, Mr. Engblom is hereby issued a full suspension of his NJRC license for a period of one year (365 days). Said suspension shall begin on March 15, 2024 and run through March 14, 2025 inclusive.

Status as of 5/14/2025 - Stay - The New Jersey Racing Commission ("Commission") is in receipt of a notice of appeal and request for a stay from Andrew R. Benedict, Esq. on behalf of his client Per Engblom. By Ruling No. 24MDH35, dated February 15, 2024, trainer Per Engblom was issued a three-hundred-eighty day suspension, a \$6,000 fine, disqualification of purse, and 8 Multiple Medication Violation ("MMV") points by the Board of Judges at Meadowlands Racetrack for violation of N.J.A.C. 13:71-7.29(a)13, N.J.A.C. 13:71-23.1(a)(b)1, and N.J.A.C. 13:71-23.6(a)(b)(c)(d) in connection with a positive test result in the horse "Mon Amour" when it completed in the 6th race at Meadowlands Racetrack on April 29, 2023. On January 2, 2025, Administrative Law Judge ("ALJ") Thomas R. Betancourt issued an initial decision, which affirmed the finding of violations and all penalties except the three-hundred-eighty day suspension which he reduced to ninety days. On March 19, 2025, the Commission determined to modify the initial decision. The Commission found that the appropriate penalty should include a three-hundred-eighty day suspension as ordered by the Board of Judges in Ruling No. 24MDH35. The Commission issued a Final Decision, dated April 23, 2025, setting forth its decision and modifications. The Acting Executive Director, having considered the request for a stay, hereby grants a stay of the penalties pending a final determination by the New Jersey Superior Court, Appellate Division. Related rulings: 25TRH5, dated April 23, 2025; 24TRH10, dated February 28, 2024; 24MDH35, dated February 15, 2024.

POSITIVE TEST- POST RACE

Trainer Michael Hall was the trainer of record on horse COVENTRY HALL in the 12th race on December 18th, 2024, at Rosecroft Raceway. Post-race analysis of blood sample #E721121 taken from COVENTRY HALL identified the presence of ADB-Fubinaca. This was identified by the primary Maryland Racing Commission laboratory, Industrial Laboratories. At Hall's request, a split sample was sent to the University of California, Davis for confirmatory analysis, which confirmed the presence of ADB-Fubinaca in the blood. As a result, Hall is fined \$2,500.00 and must return all purse monies. Given credit for 76 days served (last training start at Bally's Dover on February 27th, 2025), Hall will be issued a 284-day full suspension from May 14th, 2025 through February 21st, 2026. During this suspension, he and all horses trained and/or owned by him are barred from the grounds under the jurisdiction of the Maryland Racing Commission. Additionally, COVENTRY HALL is disqualified, finishing first and placed ninth. Once Hall's suspension is completed, he must reapply and receive approval from the Maryland Racing Commission to obtain licensure. Aggravating and mitigating factors were considered in the determination of this ruling. All purse monies must be returned within 72 hours of this issuance, and all fines are due within 10 days of the ruling. COMAR: 09.10.03.04.B. Six Multiple Medication Violation (MMV) points assessed.

Rule 4120.2; 4120.4; 4120.5; 4120.3(A)(15) On April 30, 2025, the New York Dug Testing and Research Program reported to the New York State Gaming Commission that post-race blood sample #CV3554697 and post-race urine sample #CV3554692, submitted by the horse JM'S DELIGHT, 1st place finisher in race 4 on April 9, 2025, at Monticello Raceway, contained the presence of Guaifenesin and Dextromethorphan. Pursuant to New York State Gaming Rules 4120.2; 4120.4; 4120.5; 4120.3(A)(15), Trainer Greg Merton is hereby fined the sum of \$1,500.00 and suspended for 15 days. Further, JM'S DELIGHT, is declared disqualified from said race and all purse earnings shall be returned and redistributed to

appropriate finishers and must re-test negative for Guaifenesin and Dextromethorphan prior to being eligible to race. Having appeared before a representative of the NYSGC and waived the right to a formal hearing and appeal, the fine is hereby reduced to \$750.00 and the suspension reduced to 7 days. During the term of his suspension, Greg Merton is denied access to all course and grounds under the jurisdiction of the New York State Gaming Commission.

Blood Sample #925097 collected at Northfield Park on 3/29/25 from the horse She Knows It All was found to contain Dexamethasone at a concentration of 599 +-32 picograms per milliliter of plasma. This exceeds the Regulatory Threshold of 5 picograms per milliliter of plasma adopted by the OSRC. Mr. Moore Waived his right to a hearing. He is hereby fined \$1000 and suspended for 10 days (First Offense in the last 365 days). She Knows It All is disqualified and as a result of the disqualification all purse money must be returned for redistribution (\$2500.00). Blood sample #927203 was tested by the Ohio Department of Agriculture ATL and was found to contain Diphenhydramine, a Class 3 drug. Blood sample #927203 was provided by #5 Control Sicily, who finished 1st in race 13 on 3/25/25 at Miami Valley Raceway, and was trained by Mr. Tharps. #5 is disqualified and placed 10th, the purse earnings of \$3500 are ordered to be returned to Miami Valley Raceway to be redistributed accordingly. Mr. Tharps waived his rights to a hearing, split sample and DNA tests. This is Mr. Tharps first medication violation in the last 365 days. Mr. Tharps is fined \$1000 and given a 15 day full suspension or a \$1000 fine and a 7 day (5/13/25-5/19/25) full suspension if not appealed. The fine and purse must be paid within 10 days of this ruling. During his suspension, Mr. Tharps is denied the use and privileges of all the grounds sanctioned by the OSRC. All horses owned and/or trained by Mr. Tharps may only be transferred by the Judges at Scioto Downs or the OSRC. Mr. Tharps has 48 hours to appeal this decision to the OSRC.
